Index Demographics (IDM-1)

Item-specific Instructions:

- **Item 1:** When possible, record the participant's complete birthdate (day, month, year). If the participant does not know his/her complete date of birth, leave all the date boxes blank and record the participant's age in the boxes provided. Use the participant's best estimate if the exact number of years is unknown. Do not record both a date of birth and age.
- **Item 2:** Biological sex is the participant's gender at birth. If the participant is transgender male to female, mark the "male" box. If the participant is transgender female to male, mark the "female" box.
- **Item 3:** If the participant has more than one wife, mark the "married" box.
- **Item 4:** Record the participant's average monthly **household** income over the past 12 months in local currency. Include all sources of income to which he/she has access. If the participant reports income of more than 9,999,999 in local currency, record "9999999."
- **Item 5:** Record the participant's average monthly **personal** income over the past 12 months in local currency. If the participant reports income of more than 9,999,999 in local currency, record "9999999."
