RE: **MTN 016 Visit Adherence, Completion of Procedures by Site Report**

Purpose

To summarize, overall and by site, completion of required and expected follow-up visit procedures.

Definition of Required and Expected Procedures

Refer to the protocol and/or the Study-Specific Procedures Manual for required procedures at each follow-up visit.

Protocol-required follow-up visit procedures are expected only once the visit window has closed, and only for participants who attend the visit. If a participant misses a visit, as documented by a Missed Visit Case Report Form (CRF), the procedures for that visit will not be included as expected.

Definition of Completed Procedures

Completion of a procedure is defined by specific data elements on the CRF. For example, for laboratory assays, the assay is counted as completed if a result is present on the appropriate CRF. For other procedures, a completion date, completion time, and/or response of “yes” or “stored” on the appropriate CRF may be the indication that the procedure was completed.
